CONDITIONS OF PLAY:

- 1 All matches will be played under the rules of the N.Z.T.T.A. Inc.
- 2 Ball: The Halex 3 star ball will be used for all matches.
- 3 Dress: Players shall not wear light coloured clothing. Rubber soled tennis shoes must be worn. No street shoes allowed on stadium floor. The Tournament Manager reserves the right to scratch any player who does not conform to these requirements.
- 4 The N.Z. Executive Committee will seed the draw.
- All Open Championship events shall be the best of five advantage games of 21 points up; all junior and other events shall be the best of three advantage games of 21 points up.
- 6 The "expedite rule" will be enforced. A copy of these rules will be posted in the building.
- 7 Play shall be continuous from the first service until the match be completed, provided that when necessitated by circumstances not within the control of the players, the Umpire shall suspend play for such period as he may consider necessary. Play shall never be suspended for the purpose of allowing a player to recover his or her strength or wind. The Umpire shall be the sole judge of intentional delay, and after giving warning, he may disqualify the offender.
- 8 The Referee's decision in any dispute on a point of law is final. The decision of the Umpire on a point of fact is final.
- 9 The amount of back play is 13 feet 6 inches and the distance between tables is 11 feet 9 inches.
- 10 Lighting as approved by the N.Z.T.T.A. will be used.
- 11 The number of tables is 8.
- 12 The Tournament is under the control of the Tournament Manager, Mr F. T. Powell, and Mr D. C. Mills is Deputy Tournament Manager.
- 13 The Referee is Mr V. H. Hurrey and the Deputy Referee is Mr M. J. Mellelieu.
- 14 Matches will commence at the time scheduled above unless otherwise advised. The Tournament Manager reserves the right to scratch any player who arrives late.
- 15 Competitors must report to the control table on arrival.
- 16 Entries received after the closing date (Wednesday, 22nd June, 1966) and entries not accompanied by the required fees will definitely not be accepted (exchange must be added to cheques).
- 17 Juniors under 16 years of age will be permitted to play in both age groups as well as the open events. Competitors are warned that in the event of any dispute regarding the eligibility of competing in the age group events it may be necessary to demand verification of the date of birth.
- 18 Entrants in Junior events must have their age certificates properly attested by the completion of the certificates on the Entry Form,
- 19 Billets: Junior players requiring billets must apply on the form enclosed with this entry form.
